Dear Parent/Guardian:

As of December 2024, MCAS scores are no longer used to determine a student's Competency Determination (CD) for graduation purposes. As mandated by federal and state law, participation in the Massachusetts Comprehensive Assessment System (MCAS) testing program continues to be a requirement for all students. The assessment serves several important functions in the evaluation of student achievement and school performance. Specifically, MCAS is required for the following purposes:

- All first-time grade 10 students must participate in MCAS testing
- Results are used for school and district accountability reporting
- Scores determine eligibility for:
 - The John and Abigail Adams Scholarship
 - The Stanley Z. Koplik Certificate of Mastery Award

The state is continuing the Next-Generation MCAS tests for ELA, Mathematics, and Science (Biology) for grade ten. These tests will be given electronically.

In order to facilitate this testing effectively, please review the following information carefully:

- We will be conducting an "Infrastructure Trial" for all grade 10 students on March 12, 2025. It is imperative that your children bring their Chromebooks fully charged to school that day.
- During the Infrastructure Trial, all grade ten students will be reporting to their testing rooms and completing a practice MCAS test using the testing application on their Chromebooks.
- It is very important that your child be present on March 12. Please call the school if your child will be absent for any reason.

On Tuesday, March 25th we will be administering the **MCAS ELA Session 1** and on Wednesday, March 26th we will be administering the **MCAS ELA Session 2** to all sophomores at Blue Hills. On each day of testing, students are required to bring a fully charged Chromebook to school in order to complete the testing. If your student is having an issue with their Chromebook, please remind them to contact the IT Department here at Blue Hills to get the problem fixed.





Medical documentation is required for any student who misses a test session. The documentation will be required the first day the student returns to school. Please call the attendance office if your child is ill on an MCAS test day.

We know this can be a stressful time for young people. We ask that on these days you do everything possible to be sure that your child arrives at school well-rested and on time. In return, we'll do everything possible to provide a supportive and encouraging environment. In addition, we will provide breakfast and snacks, as well as lunch for any student who requires extended testing time.

We will be meeting with the students both before the Infrastructure Trial and the actual testing dates to review the following:

- Testing will begin by 8:00 a.m. Promptness is essential.
- MCAS test regulations will be followed precisely.
- Students must bring their school-issued fully charged Chromebook to each testing session.
- No cell phones, smartwatches, or electronic devices (except Chromebooks) are allowed
 to be in a student's possession during testing. All cell phones and smartwatches will be
 collected by the test proctor. Students' names should be on phones/electronic devices.
- No notes can be brought to the testing room.
- Students can bring materials to the testing room to work on after testing. The test proctors will direct the students where to place such materials in the testing room.
- The MCAS is an untimed test; however, the school day cannot be extended.
- During breaks and after testing, students may not discuss the tests.

Any violation of the above testing regulations will result in the voiding of the test and appropriate notification to the Massachusetts Department of Elementary and Secondary Education.
