Overview of the BHR Retirement System

Mr. Gisondi presented an annual review of Blue Hills' Retirement System including Investment Returns, History, and Asset Allocation.

After Mr. Gisondi completed his presentation of the 2021 Annual PERAC report of the Blue Hills Retirement System, he requested that DSC consider and vote on a stipend increase for the Blue Hills Retirement System, Retirement Board Members. The requested increase of \$100 per month (\$1,200 per fiscal year) for each member, increasing their annual stipend to \$4,200. The \$4,200 annual stipend to be effective beginning with the current fiscal year (July 1, 2022 – June 30, 2023).
